I do not understand why there is a standard charge for water and sewer services at Serene Lakes. I believe that water charges should reflect usage and/or size of building rather than one standard charge for all, irrespective of size, value, and water and sewage usage of the building.

Please consider adjusting charges for water so that they are equitable, particularly for those like my family who have chosen to live responsibly and conserve our limited precious resources.
